Specially trained negotiators qualify former residents in real financial hardship for special payment plans that assure recovery without driving them into hiding – or into bankruptcy.

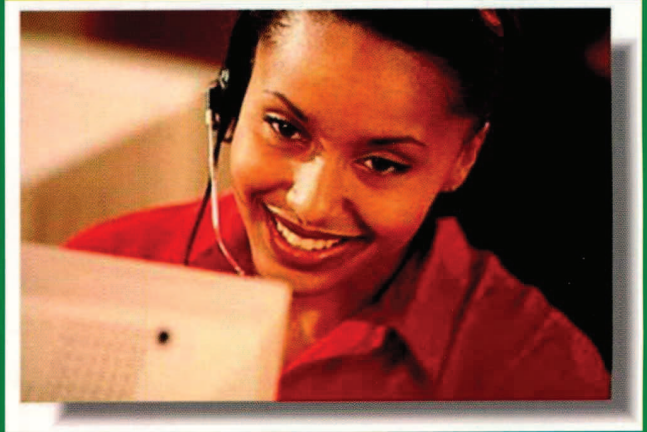
